Democrats' Investments in Their Multiracial Coalition Are Already Paying Off

In January the Democratic Congressional Campaign Committee (DCCC), the campaign arm of House Democrats, announced a historic eight-figure investment to reach the Asian American, Native Hawaiian, Pacific Islander, Black and Latino communities ahead of the 2024 elections. This monumental investment will help to ensure Democrats can restore responsible leadership and take the House back from the grips of Republican chaos.

We know voters of color are critical for Democrats' path to taking back the House — and we are taking nothing for granted. Voters of color — like all Americans — are concerned about the rising cost of gas, housing and groceries, being able to afford their medications or go to the doctor if they get sick, and making sure their kids are safe from gun violence in school. Just as in prior years, we are going all in this election to make the case to these communities that Democrats not only understand these issues but are also the party that will concretely address them.

Hochul Declares Victory With \$237B New York Spending Plan

Gov. Kathy Hochul announced a \$237 billion budget agreement with state lawmakers on Monday with a message: The doubters were wrong.

The governor waded this year into politically nettlesome issues like housing, public safety and support for the thousands of migrants who have arrived in the state over the last two years.

In the end, Hochul largely got what she wanted from the state Legislature despite calls for greater support for low-income renters and skepticism from her fellow Democrats over increasing penalties for people who steal from retail stores and assault workers.

All are issues that have been hot-button concerns for voters in New York and could loom large in the coming elections this year. The policy victories could also provide a boost for Hochul, who has recorded lukewarm job approval and favorability ratings with voters during much of her tenure.

"I heard way too often for my tastes: That's always how it's been done. That's never worked for me, it never will," Hochul said at a Capitol news conference announc-

ing the tentative agreement. "We had some very tough conversations for how we can change the entrenched status quo."

The spending plan adds about \$4 billion in additional spending from Hochul's initial proposal in January and does not include hikes to the state's personal income tax. Democrats and labor unions were also able to win changes to a less-generous pension tier first created 14 years ago that is expected to cost taxpayers an additional \$400 million annually, according to an analysis by the independent watchdog Citizens Budget Commission.

While in the majority, House Democrats worked to address key economic concerns that are consistently top of mind for voters of color.

Through the Inflation Reduction Act, we capped the price of insulin for Medicare recipients at \$35. Data has shown how much this positively impacts communities of color, as Black, Hispanic and American Indian/Alaska Native adults have higher rates of diabetes in the United States than white Americans.

And that's not all. The Inflation Reduction Act also lowered monthly health insurance premiums leading to lower costs and improved insurance rates for Asian-American, Native Hawaiian, Pacific Islander, Black and Latino communities.

Working families across this country want to know that their elected leaders in Washington will deliver on key, top-of-mind issues like lowering costs, expanding health care, protecting democracy and enshrining their essential freedoms. Yet with Republicans at the helm, this has been one of the least productive sessions of Congress in modern history.

What we've seen over the past year is undeniable: A complete disregard from Republicans for addressing the concerns of the majority of voters of color and working families. Instead, Republican control of the House of Representatives has brought us nothing but chaos and dysfunction.

Democrats stand against this tide of dysfunction, and we are committed to ensuring that voters of color understand this goes far beyond Republicans' lip service. Our historic investment in reaching these voters through persuasion and mobilization is a multifaceted, dynamic program. These efforts will cover the earliest investment by the DCCC in voter protection and education, leading to the hiring of pivotal staff who will work to understand nuances within key districts across the congressional map to develop customized strategies to combat the aggressive and discriminatory voter suppression tactics that target communities of color.

These efforts to meaningfully engage Asian-American, Native Hawaiian, Pacific Islander, Black and Latino voters include hiring local organizers to lead community outreach and increase on-the-ground presence in key races, focusing on voter registration, community events and building relationships with grassroots groups. This comes in addition to robust qualitative and quantitative research to inform our paid media persuasion and mobilization program that will meet voters of color where they are in digital, radio, mail and TV.

House Democrats know that our broad multiracial coalition is our strength.

Just a few weeks ago in the special election in New York's

3rd Congressional District, where Congressman-elect Tom Suozzi (D) beat out a right-wing Republican, Democrats made a concerted effort to organize and mobilize the Asian-American, Native Hawaiian, Pacific Islander and Latino community as an essential part of Suozzi's path to victory. This was critical in a district where nearly 1 out of every 5 voters is Asian American and was a sign of the outreach we plan to replicate in other districts across our battlefield.

Alongside investments from the Suozzi campaign, ASPIRE PAC - the "political arm of Asian American and Pacific Islander members of Congress" chaired by one of us — invested heavily in Asian-American, Native Hawaiian and Pacific Islander outreach and engagement during the special election. This includes co-hosting multiple in-language media roundtables, leveraging the ASPIRE relational organizing network for targeted phone banking and placing in-language digital banner ads in key outlets.

The ASPIRE chair and its members also campaigned alongside Suozzi in the district, including Caucus Vice Chair Ted Lieu (D-Calif.) and Rep. Raja Krishnamoorthi (D-Ill.).

It is not an understatement to say that this election will be a defining moment for our democracy. It will be a clear choice between Democrats, who fight to deliver working families what

During the office hours, local entrepreneurs and small business owners can take advantage of all that the Legal Desk has to offer and receive advice and support from Chamber staffers and expert service providers. Services will be available in several languages including English, Mandarin, Korean, Spanish and Russian.

'I am thrilled to have secured this \$1 million to create a muchneeded Small Business Legal Desk and I'm glad to see that it is now up and running and helping small businesses in our communities," said Congresswoman Meng. And despite Hochul's declaration that she had the "parameters of a conceptual agreement" with lawmakers on the budget, there was still work to be done.

Democratic lawmakers were still discussing the final details of the budget, including a contentious last-minute push to extend Mayor Eric Adams' control of public schools.

The last-minute inclusion of the issue could prolong final passage of the budget, which is now more than two weeks past its April 1 due date.

"It's an important and com-plicated issue," state Sen. Mike Gianaris said. "The members correctly want to know what's being proposed."

New York will boost funding by \$500 million to provide housing, health care, legal and job placement services for migrants, bringing total spending to \$2.4 billion.

The money is less than the \$6 billion being sought by Adams, whose city has seen 184,000 migrants arrive over the last two vears.

Still, Adams embraced the tentative budget plan as "a win for New Yorkers" — pointing to the additional migrant aid, the housing package and the potential of mayoral control being extended for up to two years as part of the spending plan.

"We've been clear that we need additional support from our partners in Albany to fully realize those goals and today we celebrate as most of our key asks were granted by our state partners," Adams said in a statement.

The final details for the state's costly Medicaid program, too, were yet to be fully ironed out.

And Hochul did not get everything laid out earlier this year. A proposal to regulate social media firms by blocking children from being exposed to algorithmicbased feeds was rejected.

Nevertheless, the broad strokes deals announced by Hochul on Monday was not an easy one to achieve.

It took Hochul two years to get a housing package in place — a concern she said was part of a broader "affordability crisis" that has led to a spike in out-migration from the state.

A prior housing package fell apart following acrimonious negotiations between the governor and Legislature last year.

At the time, Hochul had sought

measures that would have allowed the state to override local zoning in order to expand housing. Suburban lawmakers in pivotal counties around New York City, including those on Long Island, objected to the proposal.

This year, Hochul resolved to include "more carrots" - namely hundreds of millions of dollars for local governments that affirmatively opt in for more housing construction.

Hochul secured a housing package that includes \$650 million for local governments to construct more homes and new tax incentives for developers to build in New York City. The agreement came over the objections of leftleaning tenant advocates as well as some Democratic lawmakers who wanted stronger protections for renters.

"We could have settled for a watered-down plan and a hollow victory," she said. "But I refused to accept anything that didn't meaningfully address the housing supply.

Still, Republicans and some Democrats were not enamored with the details of the pending housing agreement.

New York GOP Chair Ed Cox said the tenant regulations "will only make the situation worse" for housing choices. Democratic state Sen. Julia Salazar added the housing plan is "really a missed opportunity to provide very basic protections against no-fault evictions and unreasonably high rent increases for tenants even in New York City."

Hochul was also willing to buck her party to win an agreement for stronger public safety measures as public polling has shown persistent voter anxiety over crime, and the issue has loomed large in recent elections.

New York is set to add more than 20 additional criminal charges that can be considered hate crimes.

And the state is poised to crack down on retail theft: Hochul successfully pushed for increasing criminal charges for people who assault retail workers by classifying it as a felony. An additional agreement will allow prosecutors to combine the value of stolen goods across multiple retailers and increase charges — a process known as aggregation.

The budget will include \$40 million for law enforcement agencies to crackdown on retail theft as well as enable the hiring of 100 state troopers.

Maintain School Funding education and reduce class sizes.

"To avoid more unnecessary school budget reductions as we've seen in recent years, this extension also enshrines the principle of maintenance of effort, which states that the city must use state funding to supplement, not supplant its own education funding. Of note, this year's budget builds on last year's historic fully funded Foundation Aid investment, increasing school funding by an additional \$934 million, the highest in state history.

"Finally, to add more voices to the Panel for Education Policy, this agreement adds an independent chair, increasing the number of members from 23 to 24. The Senate, Assembly and Board of Regents will submit three nominations for the chair from which the mayor may choose.

"Principles of good governance dictate that control of NYC schools not be based on the actions of any one particular mayor, which is why we will revisit the issue of mayoral control in another two years. Moving forward, we will continue dissecting the recent State Education Department report on mayoral control and engage with all stakeholders on how to best achieve long-term success

for NYC public schools. "Thank you to my colleagues in the legislature, the Adams administration, the Governor, and all the students, parents, educators, and advocates who have weighed in on the state of our school governance system, and offered insights as to how to ensure it works for the best interests of our school kids."

Legislators Announce Language Defining Squatter In State Housing Law Included In FY25 State Budget

sembly Member Ron Kim and Queens legislators today announced that the final FY2025 state budget includes language that defines squatter in state housing law. The language was derived from legislation introduced by Senator Liu and Assembly Member Ron Kim, S8996/A9772, following recent reports of squatters who take over private property.

The definition updates New York State real property law to read that "a tenant shall not include a squatter," and further define squatter as "a person who enters or intrudes upon real property without the permission of the person entitled to possession, and continues to occupy the property without title, right or permission of the owner or owner's agent or a person entitled to possession."

Including this definition in real property law will help distinguish legal renters from

take over property. It establishes that squatters are not tenants and therefore not subject to tenant rights or protections after 30 days.

State Senator John Liu stated, "It was important that we acted with urgency to send a strong message to squatters who take over private homes that they are not welcome in our community. Scam artists who intrude on others' homes should not have rights as tenants in state housing law, and this inclusion in the budget codifies that in simple, straightforward language. Defining squatter is an important step forward, and we will continue examining even stronger measures to protect homeowners without inadvertently putting renters at risk."

State Assembly Member Ron Kim stated, "Our state needed stronger protections for law abiding property owners who are being victimized by squatters. Our new law defines these terms more precisely. Any occupant who unlawfully resides in a property owner's home will be more easily removed. I want to thank colleagues in the legislature for moving expeditiously on this new law."

State Assembly Member Ed Braunstein stated, "New York State homeowners have been put on edge by the recent reports of people returning to their properties and finding squatters, only to discover that the squatters cannot be removed without a lengthy and costly eviction proceeding. Trespassing individuals in these situations are abusing a law meant to protect lawful tenants and they absolutely should not be afforded the same rights and protections. I was proud to co-sponsor this bill, which sought to close this loophole and protect New York homeowners from these unlawful opportunists. I am pleased that this clarifying language was included in this year's state budget." State Assembly Member Nily

Rozic stated, "Today signifies an important step forward as we include language defining 'squatters' in the state budget. This measure will help safeguard property rights and ensure the well-being of our communities. Thank you to my colleagues for their collective efforts to address squatting issues across New York."

State Senator Toby Ann Stavisky stated, "I want to thank my colleagues in the legislature for supporting this bill, which I cosponsored. A problem was brought to our attention, and we got positive results."

State Senator Leroy Comrie stated, "The state legislature took a hard stance against squatters who twist existing loopholes through acts that would, by any other circumstance, constitute theft. This change to the law is desperately needed, amongst our Queens residents, especially our seniors and homeowners, who have been living in fear and confusion as to how the law could possibly allow for such abuses. I am proud to stand with my colleagues to resolve this matter and hope for this bill's swift passage."

State Senator Roxanne J Persaud stated, "Squatters have jeopardized the livelihood of homeowners far too long. By passing this legislation in the budget, the rights and protections of legal renters will be clearly defined and those who take advantage will be legally held accountable. This law seeks to protect the hard earned assets of property owners and allows them to further secure their economic stability."

State Assembly Member Grace Lee stated, "In this year's budget, we are making it clear that if you are illegally occupying someone's property, you are a squatter, not a tenant. Squatters do not have the same rights and protections as lawful tenants and by clarifying this distinction, we can better protect small landlords in our communities. I was proud to be a prime co-sponsor for this bill and to fight with my colleagues to get it passed in this year's budget."

Assemblywoman Pheffer Amato Gets Rid of Insulin Co-pays for New Yorkers!

New York State Assemblywoman Stacey Pheffer Amato voted for a revolutionary change in the law for those with diabetes, or anyone who needs insulin, by banning cost sharing, or co-pays, for insulin prescriptions. Through Pheffer Amato's vote, individuals would have no out-of-pocket cost for insulin. Recent reports indicate that the average person with Type 1 Diabetes incurred annual insulin costs of \$5,705, with some paying less, and some paying more. It is widely known that when patients can't afford insulin, they resort to rationing the little medication they can afford. In fact, one study found one in four people with Type 1 Diabetes admitted to not taking their insulin as prescribed due to the cost. This shocking and deadly statistic led Assemblywoman Pheffer Amato to work on legislation to make insulin affordable for all New Yorkers.

In New York, an estimated 10% of the population, or over 500,000 individuals require insulin every day. Through this new law which was included in the 2024 State budget, Pheffer Amato helped ensure that individuals would not need to make a choice between their healthcare and personal finances. "This is a tremendous step forward for our State as we are removing a barrier between people and their health. If you need this life-saving medication, you can get it without a fear of out-of-pocket expenses. By voting yes and working on this type of legislation, I'm doing everything I can to make sure New Yorkers receive the best medical care and quality of life," said Assemblywoman Pheffer Amato.

Pheffer Amato Declares April 21-27 As 'Crime Victim Rights' Week'

Assemblywoman Stacey Pheffer Amato voted yes and passed a State-wide resolution to declare the Week of April 21st through April 27th as "Crime Victim Rights' Week." State resolutions are an extremely coveted and honored legislative declaration that preserve specific day(s) in State history. In this case, the resolution officially solidifies New York's recognition of crime victims and its firm commitment to helping them.

The Assemblywoman has been an outspoken legislator towards helping victims of crimes. In addition to the resolution, Pheffer Amato's bill, A.2724, would dramatically change the notification process for crime victims. If passed, the bill would ensure that all victims are automatically notified of the result of a criminal trial, informed of any upcoming parole hearings of their assailants, would obligate district attorneys to inform crime victims of their right to file a victim impact statement and guarantee them the ability to testify at those hearings. Currently, most crime victims are unaware of decisions, pending parole hearings, or any right they have related to testifying.

"While we have programs in New York that assist victims, I believe we need to do more. We can never forget the victims," said Pheffer Amato. The Assemblywoman continued, "I believe they have a voice, and their experience needs to be amplified in all aspects of our criminal justice system. Every victim deserves the opportunity to express how a crime has impacted their life - and I'm working to make that change in our State," said Assemblywoman Stacey Pheffer Amato.





Assemblywoman's "Smokeout Act" United New Yorkers To Close All 36,000 Illegal Smoke Shops

After weeks of negotiations, the SMOKEOUT Act passed in the State budget. The law will be effective immediately, and will allow localities across New York to quickly close the approximately 36,000 illegal smoke shops that have ballooned across our State.

Assemblywoman Rajkumar stated upon her budget victory, "On the first day of the legislative session, I pledged to all New Yorkers that I was going to close down all 36,000 illegal smoke shops ballooning across our state with my SMOKEOUT Act. It's time to smoke 'em out and shut them down. Today is a historic victory for public safety, common sense, and the health of our children. The people have spoken, and Albany has listened."

These past few months, Assemblywoman Rajkumar launched "Operation: SMOKEOUT" that brought New Yorkers together across all 5 boroughs and backgrounds with the common cause of shutting down these illegal shops. From Queens, to Harlem, to the Bronx, to Times Square, to City Hall, to Albany, New Yorkers rallied with Rajkumar to see SMOKEOUT Act to the finish line.

The SMOKEOUT Act received a slew of endorsements by the Editorial Boards of the New York Post, New York Daily News, Buffalo News, and Queens Chronicle. The SMOKEOUT Act was also endorsed by major figures and organizations including New York City Mayor Eric Adams, Sheriff Anthony Miranda, Times Square Alliance, the Partnership for New York City, the East Midtown



Partnership, the Cannabis Association of New York, the New York Cannabis Retail Association, the Bodega and Small Business Association, Silent Voices United Inc., and law enforcement across the State.

The next few weeks, Assemblywoman Rajkumar will be raiding illegal smoke shops across New York City with Sheriff Anthony Miranda, padlocking and shutting them down for good. Mayor Eric Adams, who endorsed the SMOKEOUT Act, has projected that upon the bill's passage in the budget, he can close all of the City's 3,000 illegal smoke shops in 30 days.

The SMOKEOUT Act calls for local control and for the power to shut down shops to be put in the hands of the cities and municipalities. New York City and all lo-

NYC Council Majority Whip Selvena N. Brooks-Powers **Introduces Legislation to Strengthen And Expand Wage Transparency Requirement**

New York City Council Majority Whip Selvena N. Brooks-Powers, alongside co-prime sponsor Majority Leader Amanda Farías, introduced Int. No. 808, legislation that would both strengthen and expand the city's existing wage transparency requirements. The bill would require employers to disclose information about non-wage compensation, like bonuses and benefits, as part of job postings, and would specify how employers determine the range of pay they would offer for a position. This legislation builds on the Council's yearslong effort to curb longstanding wage disparities based on wage and gender.

"Race and gender shouldn't impact a New Yorker's ability to make a living," said NYC Council Majority Whip Selvena N. Brooks-Powers. "But despite decades of advocacy and progress, race- and gender-based wage gaps persist. Pay inequity harms vulnerable communities and hampers economic growth in our neighborhoods. Wage transparency laws can help eliminate pay gaps, and I am proud to introduce legislation today that strengthens and builds upon the City's existing framework. This Council will continue to fight to remedy historic injustices and ensure a more equitable future in New York City."

"I am proud to be introducing Introduction 808 to strengthen pay parity in New York City alongside Majority Whip Selvena Brooks-Powers," said NYC Majority Leader Amanda Farias. "This legislation will expand transparency from the salary range on a job posting to also include other worker incentives like bonuses, benefits, and more. Additionally, the legislation will require that current employees are alerted of such compensation information. Our introduction expands on the work of Local Law 32 from 2022, the Salary Range Disclosure Law, and focuses on shrinking the gender pay gap by increasing access to sustainable careers.'

Women in New York City earn about 90 cents for every \$1 earned by men, and for women of color, the disparity is even starker. Hispanic women earn 54 cents for every \$1 earned by white men, while Black women earn just 57 cents for every \$ 1 by white men.

"We commend NYC Council Member Selvena Brooks-Powers and Council Member Amanda Farias for proposing amendments to address flaws in the NYC Pay Transparency Law," said Beverly Neufeld, President, PowHer New York. "Now some companies are posting overly broad ranges, current employees are in the dark about their pay status, and salary range alone is being posted, not full compensation packages. The proposed changes which expand transparency and increase compliance will advance NYC's goal of leveling the "paying field" to achieve economic well-being for women and families.'

"In 2022, the New York City Council led the way in enacting essential pay transparency protections that brought us one step closer to achieving pay equity for women and people of color," said Seher Khawaja, Director of Economic Justice & Deputy Legal Director, Legal Momentum. "Thanks to the leadership of Council Member Selvena Brooks-Powers, we are taking the next step. Building upon lessons learned, this bill will close problematic loopholes in our law and enhance transparency, further empowering workers to advocate for fair pay while motivating employers to pay more equitably."

"New York has made great strides in recent years to strengthen and expand pay transparency," said David R. Jones, President and CEO of the Community Service Society of New York. "But despite strong pay equity laws, gender and racial wage gaps persist. Today, with legislation introduced by City Council Member Selvena Brooks-Powers, New York takes a crucial step forward in closing gaps in the current transparency laws and putting our city on a path toward eliminating pay inequities holding back the economic potential of women and people of color. We applaud Council Member Brooks-Powers, Council Member Farias, Speaker Adams and the City Council for its leadership on this issue."

"This bill is crucial in assuring meaningful salary transparency, which in turn furthers broad goals of equal pay for all workers," said Miriam Clark, NELA/NY Legislative Chair.

"We have seen employers abide by the exact wording of the law but not the intent of the law, posting salary ranges that were shockingly disparate to the point of not being realistic," said CWA Local 1180 President Gloria Middleton. "The law that was intended to help women does not go far enough to make a real difference. By strengthening the pay transparency law we have on the books will go a long way to making sure that there is a level playing field for more women. This will clarify what it means to list a true and accurate pay range in job postings."

This legislation extends Majority Whip Brooks-Powers' years of wage advocacy, including as part the Fight for \$15, a global campaign to raise the minimum wage. The bill's sponsors will next work with advocates and members of the City Council to move this legislation forward.

Assemblywoman Passes Sought After Recruitment and Retention Benefit For NYPD



Assemblywoman Stacey Pheffer Amato successfully negotiated benefits for the members of the NYPD after intense conversations in the 2024 State budget. The Assemblywoman serves as Chairwoman of the NYS Committee on Governmental Employees which oversees all legislative action related to pensions, retirement systems, and the State civil service. After the vote, the Assemblywoman received hundreds of emails and calls from members of the police explicitly saying "Thank you Stacey!"

Pheffer Amato worked handin-hand with the NYC Police Benevolent Association (PBA), the union that represents NYC police officers, to craft language that would increase the salary of police officers who have served for 25 - 30 years in order to combat the ongoing issue of retention and recruitment within the NYPD. This resulted in that NYPD Officers who serve 25 years will receive the pension of a third grade detective, and NYPD Officers who serve 30 years shall receive the pension of a sergeant. According to salary data, it is believed that these benefits could translate to a potential pension payment enhancement of \$10,000 per year, or more, respectively.

"Every day our police officers put their lives on the line to protect our communities. They are out there to keep us all safe, which is why I think it is important that they be compensated for their dedication and hard work. By ensuring my bill, A.5202, was in the State budget, our State is making it clear that we not only recognize their hard work, but finally show our true appreciation for our police," said Assemblywoman Pheffer Amato.

PBA President Patrick Hendry said, "We have lost far too many of our most talented, experienced police officers to retirement or other policing jobs with better benefits. This important retention incentive will help keep our best cops on the job and in the New York City communities they know best. We are very grateful to Assemblymember Pheffer Amato for introducing this legislation and fighting hard to get it included in the budget. This legislation isn't just good for police officers - it's good for the safety of all New Yorkers."

Assemblywoman Pheffer Amato has also received praise for being the fiercest supporter of the NYPD and actually getting legislation accomplished to benefit police officers. Throughout the 23rd Assembly District, there are over 281 NYPD police officers, along with their families, who could benefit from this pension enhancement sponsored by the Assemblywoman. Pheffer Amato is known for actually doing something to help the police, not just talking about supporting them. This stems not only from this year's benefit, but also last year when she negotiated that Tier 3 NYPD Officers would finally obtain the ability to borrow from their pension - something that they had been explicitly denied.

Con Edison Researchers Earn Coveted Awards For Findings To Advance Clean Heat And Help Stymie Climate Change

They Are Among 10 Company Winners Whose Work Enhances Safety. Reliability and Aids the **Clean Energy Transition**

Three Con Edison employees have won prestigious awards from the energy industry's top research organization for a study into options for heating buildings with electricity and moving them off of fossil fuels.

The research fits perfectly with Con Edison's Clean Energy Commitment to help achieve New York State's climate and renewable energy goals. Heating buildings with electricity, as opposed to fuels like oil, natural gas or propane, is essential to creating a low-carbon future equitably and efficiently with every New Yorker sharing in the benefits.

The members of the team that worked on the clean heat project are among 10 Con Edison employees who won Technology Transfer Awards from the Electric Power Research Institute, or EPRI.

The group that studied building electrification included: Shuchita Prakash, a director in the company's Strategic Planning group; Sarah Murphy, an analyst in Strategic Planning; and Terrell Skipper, strategy manager in Customer Clean Energy Programs.

"Our great workers apply their expertise and curiosity every day to come up with new strategies to reduce greenhouse gas emissions and ensure a safe, sustainable region and planet for generations to come," said Matthew Ketschke, the president of Con Edison. "We are proud to see their contributions earn recognition from EPRI, the pre-eminent organization when it comes to energy research."

The study, "Assessment of Building Electrification Technologies for New York State," published in May 2023, examined the effectiveness of the technologies landlords and owners can use to heat their buildings with electricity. The study looked at each technology's effectiveness when it comes to reducing emissions, the economics of the technologies and their impact on the state's electricity needs.

Con Edison offers customers incentives for switching to geothermal and air-source heat pumps for their space heating.

Geothermal heat pumps rely on the constant underground temperatures to heat and cool a building. The systems transfer heat inside during cold winter months and then remove heat during summer.

Air-source heat pumps move heat from inside a building to the outside like an air conditioner. In winter, they pull heat from outside and bring it into a building.

The other Con Edison Technol-

ogy Transfer Award winners are: Jade Wong, project manager in Research and Development. She was part of a team whose research will help ensure that utilities get the greatest benefit from transmission lines without affecting reliability or safety and while complying with new federal regulations.

Transmission lines carry power long distances and feed it into utilities' local distribution systems like Con Edison's in New York City and Westchester County.

 Brenda Hill, project specialist in Research and Development; Prakash Kothari, a department manager in Environment and Sustainability; and Steve Labudzinski, also a project specialist in Research and Development.

They were part of a team that developed and tested a batteryoperated tool utility workers can use to remove manhole covers. EPRI said the tool could "have a dramatic impact in reducing ergonomic risk" for workers who remove covers, which can weigh up to 300 pounds.

Richard Alcalde, technical specialist in Corporate Security; Serena Lee, project manager in Research and Development; and Piotr Lisowski, senior specialist in Corporate Security.

The team developed and tested technology that collects in-depth forensic data about certain utility equipment that the utility can use after a cyberattack to determine whether the equipment was compromised.

Con Edison's showing in this year's awards continues the company's long-standing success in earning recognition from EPRI. The company and its employees regularly win multiple Technology Transfer Awards.

2021 to 593 in 2022, or almost 1 robbery for every 2 smoke shops. In 2023 alone, there were five fatal shootings in smoke shops, including one in Assemblywoman Rajkumar's district.

Often these unlicensed smoke shops also sell other contraband including untaxed cigarettes and psychedelics. Some offer edibles appealing to children, packaged to resemble sugar cereals and other popular children's snacks. Shops are opening across the street from schools.

Cannabis products from illegal shops even present a danger to the users. A random sampling of illegal smoke shop cannabis products found that 40% contained dangerous contaminants such as E. coli, salmonella, lead, and pesticides. None met the safety

standards of New York's legal cannabis.

Besides breeding crime and endangering neighborhoods, illegal smoke shops unfairly compete with the legal cannabis dispensaries authorized by the Cannabis Law of 2021. These legal operators underwent a lengthy licensure process and sell rigorously tested and regulated cannabis. Legal shops cannot meet the prices of illegal shops' unregulated cannabis, and there are only 108 legal dispensaries across the State. This undermines the legalized cannabis program's intent to provide economic empowerment to people who were impacted in the past by Draconian drug laws, and to reinvest in communities that were historically targeted for enforcement.

Assemblyman Colton Applauds Retail Theft Deterrent Measures Passed as Part of FY2025 Budget

A package of measures to combat the scourge of retail theft is among the public safety initiatives passed in conjunction with the Fiscal Year 2025 budget with the strong support of Assemblyman William Colton (D-Gravesend, Bensonhurst, Bath Beach and Dyker Heights).

"I am delighted that Governor Hochul, the Assembly and the State Senate have agreed on these important actions to crack down on retail theft in New York City and across the state." said Assemblyman Colton.

The multi-pronged approach to retail theft includes elevating the penalty for assaulting a retail worker from a misdemeanor to a felony, permitting prosecutors to combine the value of goods stolen from several stores by the same individual or individuals in order to raise the penalty for such theft, and going after third-party sellers of stolen merchandise by creating a new category of crime, fostering the sale of stolen goods, which will be a Class A misdemeanor.

In addition, the state budget includes \$40.2 million that will be used to create dedicated Retail Theft Teams within the state police, local district attorney's offices and local law enforcement which will focus on the issue. The budget also includes a total \$5 million tax credit for small businesses that invest in retail theft prevention measures, with businesses that meet the spending threshold eligible for a \$3,000 state tax credit.

"This focus on retail theft – which has been an

increasing problem over the past several years - will aid our small businesses which are so hard-hit by criminals who steal from them, often in order to resell their ill-gotten gains online," Assemblyman Colton said.

Other public safety measures passed in conjunction with the FY 2025 budget include a crackdown on illegal cannabis shops, an expansion of the definition of hate crimes and an increased penalty to deter assaults on transit workers.

"These important measures will help improve safety throughout the city and state through a combination of enforcement and deterrence, at a time when residents are demanding increased security on public transportation and on city streets," Assemblyman Colton said.



Established in 1958, the NYS Building & Construction Trades Council represents over 200,000 unionized construction workers in New York State.




