### As Tax Day Approaches A.G. Schneiderman Releases Consumer Alert About Frequent Tax Season Frauds

With this year's tax day just a month away, Attorney General Eric T. Schneiderman provided taxpayers with a variety of tips to help them avoid fraudulent tax schemes. The Attorney General also urged New Yorkers to stay vigilant and report to his office any suspected scams intended to steal personal and financial information from consumers.

"Too often, fraudsters use tax season as an excuse to exploit consumers," said Attorney General Schneiderman. "My office will won't hesitate to act if New Yorkers are being ripped off. This is why we ask consumers to remember a few helpful tips and notify my office of any fraudulent tax schemes."

Each year, the Office of the Attorney General receives complaints from consumers about various tax-related schemes. The Attorney General's Office continues to receive numerous complaints about scammers who are impersonating IRS officials and attempting to collect bogus tax debts. These often include fraudsters posing as government officials via phone calls or emails. Scammers threaten consumers with lawsuits or arrests if they do not turn over money or provide sensitive personal information. Consumers should not engage this type of caller or provide any

personal information. A sample IRS scam call can be found here.

In many cases, the scammers claim consumers owe past tax debts and insist that consumers pay using a pre-paid credit card or gift card. Many scammers insist that would-be scam victims pay using these products, because they are generally difficult to trace. Consumers should not pay – the IRS and legitimate government agencies will never demand immediate payment or payment information over the phone.

New Yorkers can report potential scams to the Attorney General's office by submitting a complaint here or by calling the Attorney General's consumer hotline at 1-800-771-7755. Scams should also be reported to the U.S. Treasury Inspector General for Tax Administration at 800-366-4484.

Taxpayers should be wary of tax preparation businesses that advertise low fees to get the customer in the door but then increase the final fee by hundreds of dollars claiming the tax return was more complicated than anticipated; and of a tax preparer who electronically withdraws more than the agreed upon fee without notice to the consumer.

In order to help New Yorkers avoid tax scams the Attorney Gen-

eral's Office offers the following additional tips:

- If you owe money, you will receive a legitimate notice in writing that identifies the agency and the reason you owe money;
- Do not give out personal information, including your Social Security number, bank account information, or other payment information, to telephone callers;
- Legitimate government organizations will never threaten arrest or deportation for failure to pay a debt;
- Legitimate government agencies will never insist that consumers pay a debt only via a pre-paid credit card.

The following suggestions will help consumers file their tax returns safely and keep more of their return:

- If you use a tax-preparation service, use only established and recognizable companies;
- Check the tax preparer's qualifications and history through the Better Business Bureau (org);
  Ask for a written estimate of
- all fees; avoid those who base their fees on a percentage of your refund;
   Avoid tax preparers that promise cash for preparing the return, but in fact merely offer a discount on inflated fees;
- Make sure the tax preparer is

accessible, even after the April due date;

• Never sign a blank return;

- Review entire return before signing;
- Make sure the preparer signs the tax form and includes a Preparer Tax Identification Number (PTIN);
- Consult New York's "Consumer Bill of Rights Regarding Tax Preparers"

Consumers can avoid the costs of refund anticipation loans and checks by filing their return electronically and having refunds either mailed or directly deposited into their own bank account.

The Attorney General is also reminding New Yorkers that there are Volunteer Income Tax Assistance (VITA) sites where consumers can get their tax returns prepared free of charge. For more information about how to qualify and identify a VITA location site go to: www.irs.gov/individuals/article/0,,id=107626,00.html.

Attorney General Schneiderman reminds New Yorkers that in addition to being vigilant consumers, they should also report instances of fraud to his office. Consumers are encouraged to file complaints to the Attorney General's office by completing and submitting a Consumer Bureau Online Complaint Form or calling 1-800-771-7755.

"This is about people's lives. During the hearing, Congressman Suozzi pressed the panel of administrators testifying before the subcommittee regarding consolidation efforts, cooperation with other government agencies, and their efforts to explore public-private partnerships to increase efficiency.

"Ensuring the safety of our nuclear security facilities throughout the country is a top priority. As we continue to develop our nuclear deterrent, we want to take care to maintain our current facilities and ask ourselves if there are ways we can do better," said Suozzi.

Back in the district, Congressman Suozzi travelled to Hicksville to visit the DaVita Dialysis Center as well as Nassau Candy. He also sat down with the North Oyster Bay Baymen's Association and New York State United Teachers.

"I am glad I got to meet with the businesses and organizations that serve our district. I was able to learn more about how we can work together to meet the challenges Long Islanders face in their effort to enrich our communities," said Suozzi.

### **Governor Cuomo Announces Cashless Tolling to Begin on Rockaway Bridges on April 30**

Cashless Tolling Will Reduce Congestion and Improve Travel Time at Rockaway's Major Crossings Ahead of the Summer Travel

Rockaway Resident Rebate Program is Unaffected by Switch to Cashless Tolling

Cash No Longer Accepted on Bridges Beginning April 30

Commuters with Leftover Tokens are Encouraged to Sign Up for E-ZPass and Will be Eligible for Token Refunds

Governor Andrew M. Cuomo today announced cashless tolling will begin on the Marine Parkway-Gil Hodges Memorial and Cross Bay Veterans Bridges in Queens on April 30. The transition to cashless tolling is a major component of the Governor's plan to reimagine New York's crossings for the 21st century and will reduce congestion and improve travel time at Rockaway's major crossings ahead of the region's summer travel season. The Rockaway resident rebate program is unaffected by the switch to cashless tolling.

Beginning April 30, cash and metal tokens will no longer be accepted at either bridge and commuters with leftover bridge tokens are encouraged to transition to E-Z Pass and will be eligible to redeem their tokens for a refund. E-ZPass will provide the best rate for all drivers, including Rockaway residents. Electronic tokens or E-Token E-ZPass plans will also be available starting April 30, 2017.

"The Rockaway Bridges are vital arteries for the Queens community and we are taking action to reduce congestion, increase safety and streamline the commute at these crossings," Governor Cuomo said. "The transition to cashless tolling at these bridges is an important milestone in our plan to reimagine New York City's crossings for the 21st century and we will continue investing in our transportation infrastructure to meet the needs of current and future generations of New Yorkers."

Open road tolling will be completed at all MTA bridges and tunnels by the end of this year. The schedule is as follows:

- RFK Bridge Summer 2017
- Verrazano-Narrows Bridge -Summer 2017
- Throgs Neck Bridge Fall 2017

Bronx-Whitestone Bridge -The Rockaway Bridges join the

Henry Hudson Bridge, Hugh L. Carey and Queens Midtown tunnels, where sensors and cameras suspended over the highway on structures known as "gantries" read E-ZPass tags and take license plate images, so vehicles no longer have to stop and pay the toll. Vehicles with E-ZPass tags are automatically charged, and vehicles without E-ZPass have their license plate recorded and a bill is mailed to the registered owner of the vehicle. E-ZPass tags should be mounted inside the vehicle's front windshield.

Current token users may use tokens for Rockaway Bridge tolls through April 29, 2017. Leftover tokens may then be easily redeemed by visiting one of the E-ZPass New York Customer Service Center walk-in centers and completing a token redemption request, or by calling 212-360-3000, selecting option 6 and requesting a token refund kit. Resident token users will be mailed information from MTA Bridges and Tunnels with instructions on how to transition from tokens to E-ZPass. Non-resident token users can go to mta.info/e-zpass to get more information on opening an E-ZPass account.

Cashless tolling is projected to save commuters up to 21 hours of drive time every year. Additionally, it reduces emissions and significantly decreases the amount of fuel burned by drivers, who will no longer have to stop and start waiting to pay tolls. This will conserve approximately one million gallons of fuel and save \$2.3 million each year.

'I am excited to see Cashless Tolling come to the Rockaway Bridges, and believe the benefits of this technology will enhance traffic flow, reduce congestion and decrease commute times making it easier for New Yorkers to get where they need to go," said Veronique Hakim, MTA Interim Executive Director. "The accelerated schedule we are undertaking to bring Cashless Tolling to all of our facilities in 2017 underscores our commitment to investing in New York's transportation network to meet the needs of a growing City."

To make it easy for drivers to pay their tolls, MTA Bridges and Tunnels has introduced a number of programs. Customers can sign up for E-ZPass and save 30-50 percent on MTA B&T tolls at MTA.info/E-ZPass even if they do not own a car. Drivers who receive a Tolls by Mail bill can pay it online at the Tolls by Mail website; by mail; over the phone; or in-person, and payment options include check, credit card, checking account, or cash. Customers who call \*\*826 from a mobile phone will receive a text with a link to the Tolls by Mail website and information on how to set up a Pay Toll Now account that can be used by rental car customers.

To ensure that all users of MTA Bridges and Tunnels toll facilities pay their fair share, a series of enforcement measures are in place to tackle toll payment evasion and chronic toll scofflaws. Customers who do not pay their tolls are subject to violation fees, registration suspensions, and other enforcement actions. Late fees accrue if an initial toll bill is unpaid, and if a second notice is also ignored, violation fees of up to \$100 per toll violation may be imposed.

The New York State Department of Motor Vehicles has enacted regulation that allows suspension of the vehicle registration of motorists who fail to pay three tolls, violation fees, and other charges resulting from violations on different days, within a period of five years, and ignore toll authorities' repeated notices.

### **Meng Issues Statement Opposing** Trump Budget Proposal

U.S. Rep. Grace Meng (D-Queens) today issued the following statement opposing President Trump's budget proposal.

"As a member of the House Appropriations Committee, there is absolutely no way I can support President Trump's budget request as it stands. His budget claims to put "America First," but I fail to see how slashing funding by \$54 billion dollars for our most vulnerable citizens is patriotic. The budget calls for a complete elimination of essential programs such as the Low Income Home Energy Assistance Program, which helps low income families, particularly those with children or senior citizens in the home, with energy costs during cold winter and hot summer months. This program provides critical heating and cooling support to over 1 million New York households. Other programs will have their funding restricted, such as the Meals on

Wheels program, which provides food to impoverished older and disabled Americans who can't leave their homes.

Every single American would be negatively impacted in some way by this budget, whether it be through the elimination of community development programs that assist at-risk communities both rural and urban; deep cuts to the National Institutes of Health, which conducts research to find cures for devastating diseases such as cancer and Alzheimer's disease; continued exposure to toxic waste due to slashed funding for the Environmental Protection Agency that cleans up these waste sites; or the termination of before- and after-school programs, particularly in high poverty areas.

My constituents deserve better than this budget. America deserves better than this budget. And I will not stop until I see something workable on the table."

### **Chairman Crowley on President** Trump's FY18 Budget Proposal

House Democratic Caucus Chairman Joe Crowley (D-NY) issued the following statement after President Trump released today a \$1.1 trillion budget that makes deep cuts to education, innovation, veterans, and assistance programs that Americans value.

'It stands beyond reason that a president who claimed to be concerned with working Americans, expanding the American economy, and keeping Americans healthy would author a budget that makes sweeping cuts to all these critical areas. It is abundantly clear that instead of investing in early education, skills training programs, and medical research, President Trump is only interested in inflicting deep cuts to the programs Americans rely on - which amounts to an assault on working families and the poor.

"Nothing about the fiscal year 2018 budget puts America on the path toward long-term security. Pumping up defense spending while stripping funding for peacekeeping and other diplomatic efforts is extremely misguided. The budget proposal also has far too little support for veterans, as it would make deep cuts to National Institutes of Health and job training programs tailored toward returning service members.

"This is not how responsible leaders should govern."

Office of General Services Commissioner today announced that the following five businesses have recently been certified by the Office of General Services' (OGS) Division of Service-Disabled Veterans' Business Development (DSDVBD):

Resilient Support Services Inc., located in Watervliet, NY, which provides general contracting, electrical/HVAC/ high voltage power systems, and support services.

Walker Diving Underwater Construction LLC, located in Hammonton, NJ, which provides marine construction, commercial diving, and underwater construction.

- Protek Government Solutions LLC, located in New City, NY, which provides system integration design services for information technology.
- HarpData, located in Buffalo,

NY, which provides technology consulting services, technology roadmaps, security design and cyber security.

Perimeter Security Inc., located in Bronx, NY, which provides security, patrol, and watch guard services.

The Division was created by Governor Andrew Cuomo in May, 2014 with enactment of the Service-Disabled Veteran-Owned Business Act. As of march 9, 2017, a total of 307 businesses have been certified.

The Act promotes and encourages participation of SDVOBs in NYS public procurements of public works, commodities, services and technology to foster and advance economic development in the State. ### **Assembly Budget Puts Families First**

Budget increases education investment by \$1.8 billion, takes steps to fund the Foundation Aid obligation, and expands access to higher education

Fixes problems with the STAR program, rejecting added hassles for seniors

Invests in quality, affordable health care to ensure access to needed care

Assemblywoman Nily Rozic (D,WF-Fresh Meadows) announced this week that the Assembly's proposed 2017-18 state budget preserves and protects programs that puts families first, including a total of \$26.3 billion in education funding, changes to the state's tax structure benefitting working and middle class families, and a \$65 million appropriation for the Metropolitan Transit Authority (MTA).

"With a federal administration proposing cuts to programs and resources, now more than ever it is important that we are taking proactive measures as a state,' said Rozic. "The Assembly took a standing in crafting and passing a budget proposal that protects the middle class and helps lift up, not push down, those struggling to get by. We are a state that looks out for one another – our proposal reflects that and moves New York forward."

Rozic says the Assembly's 2017-18 \$153.8 billion spending plan:

- Allocates \$26.3 billion in school aid, an increase of \$1.8 billion over last year, and rejects the Executive Branch's repeal of the Foundation Aid formula, beginning a four-year phase-in of the state's obligation to its neediest school districts;
- Promotes college affordability by increasing funding for opportunity programs, expanding the Tuition Assistance Program, and also including a new refundable

- credit for interest on student loans; Provides CUNY with \$100 million in capital funding to help pay for new projects, allocates \$6.5 million for community base aid, and restores \$902,000 in funding for CUNY to Child Care Centers;
- Continues a gradual reduction in personal income taxes for middle income wage earners that began last year. When fully implemented, the tax reductions will benefit about six million New Yorkers:
- · Fixes changes made last year to the state's School Tax Relief (STAR) program so that all eligible homeowners receive deserved tax relief upfront as a reduction in their school tax bill. The budget also rejects the Executive Budget's proposed changes to the Enhanced STAR program that would require eligible seniors for STAR register with the state and participate in

### Whirl With Merle

### WHERE HAVE ALL THE DELIS GONE?

I have had a craving for a kosher overstuffed tongue sandwich on rye bread. The kind that you can only get at a kosher deli. These days they are few and far between. According to Jay Parker, owner of Ben's Best, at 96-40 Queens Blvd., there were once up to eight kosher deli's just in the surrounding area of Rego Park. Now, Ben's Best is only one of two located in all of Queens County.

Jay isn't the first owner as it was being passed down through his grandparents who immigrated from Poland and Russia during the 1930's. This was the all too common story of people who would never take a hand out and sacrificing their life to better the future of their children's. They did not want their offspring to work in a deli but rather go to school and grow into a more lucrative business. At that time the grandparents worked and lived atop a canned goods store. Jewish immigrants, particularly the Ashkenazi, yearned for their own "comfort food" of the meats, soups and what were considered inexpensive "delicacies". Jay told me that back in the 1930s and once the slicing machine was invented, there were 1500 kosher delis in New YorkCity and that now there are only about a dozen.

Jay's father, Benjamin, was the first to own thisboutique delicatessen in 1945. Jay took over in 1984 after his father died, trading Wall Street for pastrami and quite happy and proud that he did. "You just can't get this stuff anywhere else".

Of the space, half is taken up by the counter and kitchen. There is no party room. Jay says he likes it this way as keeping up the quality and taste is easier to serve and satisfy a smaller amount of diners at a time.

Finished with the history. Let's get to the food. I really wanted to sample everything on the menu. I settled on what I felt were the important ones starting with Jewish penicillin. In other words, Chicken Soup with a huge Knaidel (matzo ball), thin noodles, a couple of carrot slices and pieces of chicken. It's all about the broth using whole chickens, chicken bones and soup greens. I found that there was just enough salt to taste the savored flavor. Hey, you can always add salt, but you can't take it out.

Chopped liver, for those that have never had it, is made from chicken livers. Schmaltz (chicken fat), hard boiled eggs and onions are added. All is ground up to what would be considered a chunkier pate. I recall years ago when my mother made this and she had to use a chopper rather than a food processor. The chicken fat was taken directly from a fresh kosher chicken. When fried up, there were small pieces of the crisp fat, called greeven. Great on rye bread. Chopped liver at





Ben's Best is served with slices of red onions, red peppers, black olives and some lettuce. Oy, what a great sandwich it made, not to mention the good taste. Jay has the bread specially made with caraway seeds that are totally ground. No more having someone point at your teeth.

Stuffed cabbage is another favorite of mine. Cabbage leaves are basically stuffed with ground beef and cooked rice, along with a few other ingredients, then simmered in tomato soup. I found both the taste and consistency a bit different from ones I've had before, even making it myself. Ah! The beef was ground a bit more than usual and tomato SOUP is better than tomato SAUCE. The cabbage roll is served with peas and carrots atop.

Since I have mentioned cabbage, I'll mention the cole slaw and pickles that are served with meals. Thank goodness, there wasn't vinegar in the cole slaw. Pickles are coming from a barrel and not a jar. One sour, one half sour. Perfect!

Potato pancakes (latkes) may be typical of Chanukah. You don't have to wait for the holiday. Made from grated potato (less the water), onion, matzo meal, flour, eggs and oil, they are thick. Jay has them served with apple sauce that is freshly made on the premises. Option at home is to serve with sour cream. There isn't any dairy served here.

Kasha Varnishkes are actually a Sephardic recipe that combines these buckwheat groats with farfalle bow-tie pasta. There are no meat products in this version. If the waitperson asks if you want beef gravy served on the side, ask "Which side?"

A delicious knish is a standard. What make a difference is the knishwich, a sandwich of meat served inside a knish. It's like having your meat and potatoes in a better form. All of the meats are made on the premises. Ben's Best is well known for the pastrami. I had sampled the pastrami, corned beef, brisket of beef and turkey. I could see what the pastrami rave was all about.

No, I did not forget the tongue. It is quite difficult to buy at a meat market or supermarket as I have heard from many that the Chinese discovered what they find as a "delicacy". That's right, they are shipped off to China and will pay highly for it. It's not unusual to find the price of cooked tongue here at about \$40 per pound. Jay's overstuffed sandwich has about a half pound of meat. In other words, eat it sparingly! Nurse it! Savor it! Love every bite of it! My craving has been satisfied for a while.Oy, a mechayeh!

Stressed is desserts spelled backwards. Jay said that they make their own baklava. Perfect timing as the baklava was just coming out of the oven. Twist my arm. OMG it was awesome! Aside from eating it hot, I notice that the walnuts were chopped fine. As much as I like baklava, I don't particularly want to chomp on nuts.



# **House Passes Meng Amendments** as Part of Veterans Affairs Bill



The House of Representatives passed legislation which includes two amendments authored by U.S. Rep. Grace Meng (D-NY) that would provide employment opportunities to recently discharged service members, and address staffing shortages within the Department of Veterans Affairs (VA).

Meng's first amendment would require the Secretary of the VA to establish a program that encourages members of the Armed Forces serving as health professionals to pursue jobs with the Veterans Health Administration (VHA) upon their discharge or separation from the military.

The VHA, a component of the VA, is the largest integrated health care system in the United States, providing care to millions of veterans through VA medical centers, clinics and outpatient sites.

"As we all know, the VHA has existing shortages of health professionals," Meng said on the floor of the House during the

chamber's consideration of her measure. "We also know that our service men and women sometimes have difficulty transitioning back to civilian life after serving. What could be better than having a service member with health care training and experience transition into employment with the VHA serving their brothers and sisters? Everyone wins with this amendment."

Meng's second amendment seeks to assist the VA Secretary in filling VHA positions for which there are severe staffing shortages.

Under current law, the Inspector General (IG) of the VA must issue an annual report on which positions within the agency are severely understaffed. The VA Secretary is then granted expedited hiring authority to fill those positions. Meng's provision permits the IG to report on additional shortages than those currently allowed by law so that the VA Secretary can fill those positions more quickly.

"Our veterans need the care that they have earned, and that they deserve. They need it now. The first step in that endeavor is making sure that VA staffing levels are adequate," Meng also said on the House floor.

Meng's amendments passed unanimously by voice vote. Both were approved as part of H.R.1367, a bill to help hire and retain physicians and other employees at the Department of Veterans Affairs. H.R. 1367 passed 412 to 0.

# Crowley on 'Empire State Kickback' Included in Harmful Republican Health Care Repeal Bill



House Democratic Caucus Chairman Joe Crowley (D-NY) issued the following statement after Republican leaders included a provision in the GOP health care repeal bill that would deny federal matching funds for Medicaid dollars raised in New York State counties:

"The American Health Care Act will tremendously harm New York State, its residents, and the country as a whole by ending health care coverage for 24 million Americans, raising premiums for seniors, and cutting billions of dollars from state Medicaid programs.

"And Republican leaders, upon realizing that even members of their own party were waking up to the damaging effects of the American Health Care Act, made a last-ditch play for votes by crafting a 'Empire State Kickback' provision. This provision would deny federal matching funds on any Medicaid dollars raised from counties and provide a powerful incentive for New York State to discontinue requiring county contributions altogether.

"Not only would New York City be left with the \$2 billion check once other New York counties stop paying into Medicaid, but the state would be forced to respond to the lack of federal revenue in other ways – either through cuts to services, limiting Medicaid eligibility for New Yorkers, or reducing payments to health care providers. New York State could even feel obligated to raise property taxes or levy replacement fees on counties to make up the resulting shortfall.

"The 'Empire State Kickback' is nothing but political maneuvering of the worst kind – a shameful attempt to lure political support for a bill that remains, at its core, bad policy built by a bad process. Experts have questioned whether this kickback is constitutional, much less whether it will meet Senate budget rules. New Yorkers have had enough of backroom, closed-door dealing, and this amendment, like the base bill, should be rejected as the political ploy that it so clearly is."

the Income Verification Program. Currently, seniors are able to register with their local assessor ore register when they file their income tax returns – a process that is far easier:

- Provides \$1 million for Naturally Occurring Retirement Communities (NORCs) and \$1 million for Neighborhood Naturally Occurring Retirement Communities (NNORCs), which help keep seniors in the homes and neighborhoods where they have lived much of their lives;
- Restores \$78.8 million to Medicaid programs and \$37.6 million

in public health programs targeted in the Executive Budget proposal for consolidation. The Assembly budget proposal allocates \$14.6 million to the Essential Plan, an affordable health plan for lowincome individuals and families, rejecting premium and co-pay increases;

- Invests \$700 million in capital funding for the state's health care and community-based providers, and includes over \$79 million to combat heroin and opioid addiction in our communities;
- An additional \$50 million in Consolidated Highway Improvement Programs (CHIPs) funds to help communities keep their roads

and bridges in good repair. The budget also includes allocations for the Pave NY Program, which helps municipalities to reconstruct local highways and roads;

- Rejects the Executive Budget proposal to reduce MTA funds by \$65 million. The Assembly has opted to fund a \$65 million capital appropriation to help the MTA run more efficiently for the millions of people who rely on it;
- Includes \$350,000 to create the office of the Utility Consumer Advocate, to serve as an independent advocate and represent the interests of residential utility customers who have issues related to billing or service.

### House Passes Meng Legislation Honoring 100th Anniversary Of First Woman Sworn-Into Congress

Measure would rename existing STEM grant program after former Rep. Jeannette Rankin Congresswoman had ties to NYC

As the nation continues its observance of Women's History Month, the House of Representatives passed legislation sponsored by U.S. Rep. Grace Meng (D-NY) that would honor the 100th anniversary of the first woman sworn-into Congress, former Rep. Jeannette Rankin (R-Montana).

The 100 Years of Women in Congress Act (H.R. 382), would rename the U.S. Department of Agriculture's "Women and Minorities in STEM Fields Program (WAMS)" to the "Jeannette Rankin Women and Minorities in STEM Fields Program." Rankin, in addition to being the first woman elected to Congress, was a trail-blazer in STEM (science, technology, engineering and mathematics) fields, graduating with a Bachelor of Science degree in biology in 1902.

"Today, the House fully em-

braces Women's History Month by passing my legislation commemorating the incredible legacy of Rep. Jeannette Rankin, the first woman elected to Congress, even before women had the right to vote," said Meng. "From politics to the sciences, Rep. Rankin was a true pioneer who continues to be an inspiration for women everywhere. I am grateful that my colleagues unanimously agreed to recognize her impact on our nation's history by passing the 100 Years of Women in Congress Act."

If renamed, the WAMS program would remain a competitive grants program for colleges and universities to encourage women and minorities to pursue research, degrees, and careers in STEM fields. According to the U.S. Bureau of Labor Statistics, women make up 47 percent of the total U.S. workforce, but are still vastly underrepresented in STEM fields. Although gains have been made, women still comprise only 39 percent of chemists and material scientists, 28 percent of environ-

mental scientists and geoscientists, 16 percent of chemical engineers and 12 percent of civil engineers.

Born in 1880, Jeannette Rankin represented the state of Montana in the House. She was elected on November 7, 1916, almost four years prior to ratification of the 19th Amendment to the U.S. Constitution that gave women the right to vote.

Rankin also had ties to New York City. She helped organize the New York Women's Suffrage Party and worked for the National American Woman Suffrage Association, which was headquartered in New York City. She attended the New York School of Philanthropy which later became part of Columbia University.

The 100 Years of Women in Congress Act was co-authored by former Rep. Ryan Zinke (R-Montana), now Secretary of the U.S. Department of the Interior. The legislation passed unanimously by voice vote. The bill also passed the House during the last session of Congress by a vote of 377-6.



"Almost one thousand new seats to replace the mini building and the rundown trailers will help our students learn in the environment they deserve. It will give them a better opportunity to succeed."

"This brand new, state-ofthe-art addition builds on our continued collaboration with local leaders to address overcrowding in School District 24" said Lorraine Grillo, President and Chief Executive Officer of the New York City School Construction Authority. "We are thrilled to construct a beautiful and modern learning environment for the PS 143 students to grow and thrive in and look forward to bringing these 980 new seats to Corona as fast as possible."

"Parks is happy that we were able to work with the School Construction Authority to design a solution that allows the school to expand, while also improving the recreational amenities in Louis Armstrong Park. I'd like to

Morena induced a fly out to center field to get out of the inning before any further damage can take place. The next inning, Luongo doubled the Setters lead, 2-0, before Garrett De Lotto scored on a wild pitch to extend the lead to 3-0.

The Knights struck back in the top of the sixth, as junior Thomas Parish scored on a third basemen the deficit, 3-1. Sophomore Andrew Navarez brought home senior Joe Morris with a single to left center, as the Knights got within one (3-2) with two outs. Navarez stole second before advancing to third base on a wild pitch. Junior Billy Riches looked to equal the game before a diving stop by first basemen De Lotto got the third out of the inning.

The Setters answered right back by adding insurance runs in the bottom of the sixth and seventh innings to take a 7-2 lead. The Knights refused to go away, as junior Joseph Pidoto scored on a passed walk before Parish scored on a wild pitch to cut the deficit down to 7-4. Queens threatened in the top of the ninth with one out, two on base and the tying run up at bat. However, Setters closer Michael Amato had other plans, as he picked up the save by striking out Pidoto before Setters catcher Frank Mayo got senior Kevin Kolesar caught stealing at second base to end game one.

Morena (2-1) picked up his first loss of the season, going for five hits, two earned runs and two strikeouts in three innings of work, while Setters starter Dan Wirchansky (1-2) held the Knights at bay with seven strikeouts and five hits in six innings. Kolesar, playing his first game after a four game hiatus, showed no rust, as he went for 3-for-5. Parish went 2-for-2 with two runs and walks, while Navarez (1-for 4, 1 RBI) and Riches (1 each recorded a hit.

Game Two

Queens 4, Pace 1 (F/7)

The Knights jumped on Setters starter Kyle Cashman (0-2) from the first inning, as Kolesar got hit by a pitch before juniors Paulino Harrington and Karl Klesin each singled to load the bases. Pidoto delivered with an RBI sacrifice fly to right field to score Kolesar, and Parish continued his excellent run of the afternoon with another single to score Harrington, as the Knights led 2-0 after one.

Broderick was dominant from the start, as he delivered from pitch one before giving up his first hit in the bottom of the third before, striking out the side, as the Setters were unable to pick up his speed and pitches. The Knights doubled their advantage in the top of the fourth to help their starter, as Queens went up 4-0 behind Klesin and Pidoto RBIs. In the bottom of the sixth, Broderick ran into his only trouble of the evening, as John Kukura doubled with one out before scoring on a De Lotto RBI single to left field. Broderick returned in the seventh inning to strike out the side to earn his second win of the season.

Broderick (2-1) pitched a masterful game of seven innings with a season-high 13 strikeouts, allowing three hits and one earned run to earn the completegame win. Kolesar went 2-for-3 with two runs for his second multi-hit game in a row, while Klesin went for 3-for-4 with an RBI. Parish continued his form, going 2-for-4 with an RBI, and Pidoto hit 1-for-3 with two RBI.

### Pooch-Hater Tossing Splenda Packets Into Kew Gardens Dog Run

Kew Gardens dog owners are on edge because someone has been repeatedly throwing packets of artificial sweetener Splenda into their local dog run, possibly trying to hurt their pooches, they said.

"There has been multiple sightings of someone throwing Splenda packets in the Forest Park Barking Lot," dog owners posted on the run's Facebook page, adding that they needed "the dog park community to come together and help catch the perpetrators."

Some food products

can be extremely toxic, or even fatal, to dogs, like another artificial sweetener Xylitol, which can be found in chewing gum, some baked goods, mints and chocolate bars.

Splenda, experts say, is less likely to cause harm, but could still trigger intestinal distress.

"Splenda in minimal amounts — a few packets — is not toxic to dogs," said Dr. Tina Wismer, the medical director of the ASPCA's animal poison control center. But she also noted that "several cups of the sugar substitute

could cause vomiting and diarrhea."

The 9,000-squarefoot dog run, known as the "Forest Park Barking Lot," was created last June near the Overlook, and is used daily by at least 100 dogs, the owners said.

"This needs to stop!," the post written last week also read. "The park is to be a safe place for our dogs to play and have fun! Not for them to go and get sick and die there!"

Dog owners said it's not the first time that someone in the neighborhood has tried to hurt their pooches.

thank Senator Peralta for his dedication to the mental and physical wellbeing of this community," said Queens Borough Parks Commissioner Dorothy Lewandoweki

The new state-of-the art building will have a capacity for 980 students, new science laboratories, art and music rooms, and a large cafeteria. It is slated to open in September of 2020, and will be five stories high. With the new building, the six school trailers that accommodate almost two hundred first graders and the mini-building will be

emoved.

"This is a victory for schoolkids, and I want to thank the parents, P.S. 143 and the community for their tireless efforts to bring about this project," said Senator Peralta. "I want to thank the School Construction Authority, the Department of Parks and Recreation, and the Department of Education for partnering and working together to make this a reality. Our schoolchildren need this. Our schoolchildren deserve it."

PS 143 was built to accommodate about 900 students. It enrolls about 1,800, with students sitting

in six rundown trailers, a mini-building and an annex on 98th Street. "These so-called temporary classroom units, or trailers, have been here for decades. And just yesterday, students in these trailers faced frigid temperatures, making it difficult for them to learn," Senator Peralta said.

"We are very happy with this news, news about the construction of the new addition, and this wouldn't have happened without the help from Senator Peralta. He pushed for this project since the beginning," said Angélica Salgado, President of the Parent-Teacher Association at PS 143.
