Assemblyman William Colton (D – Gravesend, Bensonhurst, Bath Beach, and Dyker Heights) is outraged with the NYC council's proposal to remove historical monuments such as George Washington, Thomas Jefferson, and Christopher Columbus. Did anybody ever stop to think how much money would be wasted on this project? The money that the city is in dire need now!

"In 2022 the Christopher Columbus statue was proposed to be removed, and now NYC is facing a migrant crisis. The mayor is planning to stabilize the city's budget by slashing up to 15% from the city agencies such as NYPD, education, senior services, and sanitation, and the city council is thinking of removing centuriesold monuments. These statues are the history and legacy of this country and it's very disturbing to hear that elected officials worry more about the past than the present," Colton stated.

"Crime, homelessness is on the rise, quality of life is nearly destroyed, the middle class is struggling and barely able to survive and we are thinking of how to remove monuments. It's very disturbing and shocking. Therefore, I strongly oppose the NYC council's proposal. 

Meng Introduces Legislation Seeking Commemorative Postage Stamp in Honor of Queens' Lewis Latimer

U.S. Rep. Grace Meng (D-Queens) has announced that she introduced a House resolution calling for a commemorative postage stamp that honors the life and legacy of Lewis Latimer, a Black American inventor and patent draftsman who settled in Queens, New York in the early 1900s.

The Congresswoman introduced the resolution this month to commemorate the 175th birthday celebration of Latimer, which she attended on Saturday at the Lewis Latimer House Museum in Flushing.

The museum is Latimer's final residence. It is where he lived with his family from 1903 until his death at the age of 80 in 1928, and today, the facility highlights his work and legacy.

Latimer was the son of two escaped slaves, that eventually settled in Chelsea, Massachusetts. At 16, he joined the U.S. Navy, and served on the USS Massasoit during the Civil War. Latimer had a passion for mechanical drawings, which aided in his work in a patent law firm. He eventually took to inventing, and some of his notable inventions included an evaporative air conditioner, an improved process for manufacturing carbon filaments for light bulbs, and an improved toilet system for railroad cars. Latimer also worked with Alexander Graham Bell and Thomas Edison.

"Lewis Latimer's life and story is a real-life example of the American Dream, and a commemorative stamp honoring that story is a great way to recognize an amazing person who spent over two decades living in Queens, New York," said Rep. Meng. "Latimer's work, not only in the scientific community, but also for the advancement of civil rights for Black Americans cannot be understated. Despite his passing nearly a century ago, his contributions are still appreciated today, and honoring him with a commemorative stamp is just one way we can show that appreciation."

"A commemorative postal stamp honoring Lewis Latimer would celebrate a great Black American who, despite never progressing beyond grade school, became a legendary inventor, esteemed Edison Pioneer, and author of the early 'bible' on incandescent lighting," said Hugh Price, Lewis Latimer's great grandnephew who also serves as Vice Chair of the Board of the Lewis Latimer House Museum. "He was a corporate trailblazer who helped light America and exemplified the indispensable contributions that those who all-too-often are marginalized and excluded can make

when the gates of opportunity are open to everyone."

"Black history is American history, and Lewis Latimer is a perfect example," said Rep. Steven Horsford, Chair of the Congressional Black Caucus. "Born to escaped slaves in Massachusetts, he served in the U.S. Navy before becoming a patent draftsman. That career led him on a path that included drafting the necessary drawings for Alexander Graham Bell to patent the telephone. In his own right, he innovated designs for the lightbulb, toilets on railroad cars, air conditioning, and many other items. Today, as we work to ensure economic mobility and wealth building, it's important to recognize the story of a Black in the 19th century who, despite slavery, the Civil War, and the rise of Jim Crow, was able to carve out a path of success."

"It's an honor to play a part in recognizing Lewis Latimer and his trailblazing life," said Rep. Gregory Meeks. "As a longtime resident of Queens, Latimer was able to build a legacy as a pioneering inventor, despite the racism and discrimination prevalent in 19th century America. I believe it's critical we recognize the heritage of our intellectual leaders, and Latimer's legacy of innovation is an exemplary example for our community."

On 50th Anniversary of "Battle of The Sexes," Gillibrand, Capito, Sinema Introduce Bill to Award Billie Jean King The Congressional Gold Medal

King would be the first individual woman athlete to receive the honor

U.S. Senators Kirsten Gillibrand (D-NY), Shelley Moore Capito (R-WV) and Kyrsten Sinema (I-AZ) introduced bipartisan legislation to award the Congressional Gold Medal to tennis legend and American icon Billie Jean King. The medal will be awarded in recognition of Billie Jean King's groundbreaking leadership, throughout her life and career, in advancing equal rights for women in athletics, education and society at large. King was instrumental in securing equal prize money in men's and women's tennis at the U.S. Open, spearheaded the formation of the Women's Tennis Association and brought worldwide attention to pay equality throughout her career and in her "Battle of the Sexes" match against Bobby Riggs. Today is the 50th anniversary of the match. The House companion bill is

led by Representatives Brian Fitzpatrick (R-PA) and Mikie Sherrill (D-NJ) and currently has more than 80 cosponsors.

"Billie Jean King is a tennis legend, a trailblazing American icon and a pioneer for gender equality," said Senator Gillibrand. "From her leadership on equal rights and Title IX to her advocacy on behalf of the LGBTQ community, Billie Jean's life and career is an example of using one's platform and talents for positive, lasting change. No female athlete has ever been awarded the Congressional Gold Medal and no one could be more fitting to break this barrier than Billie Jean King."

"Billie Jean King has been an inspiration for female athletes around the world— not only for her incredible talent on the tennis court but also for her determination in fighting for women to receive equal pay. I can think of no other female athlete that has done more to advance women and girls in sports than Billie Jean King, and I'm proud to join my colleagues in introducing legislation to award her the Congressional Gold Medal for her efforts," Senator Capito said.

"Billie Jean King is an incredible athlete and unmatched trailblazer for women and girls in sports," said Congressman Fitzpatrick. "I was honored to introduce this legislation in the House, honoring her important accomplishments. And I look forward to working with my colleagues in recognizing Billie Jean's tireless advocacy for female athletes."

"Women's sports simply wouldn't be what they are today without the trailblazing leadership of Billie Jean King," said Representative Sherrill. "From her 39 Grand Slam titles and her advocacy before Congress for the passage of Title IX, to her iconic victory in the Battle of the Sexes and establishing the Women's Sports Foundation, she won greater respect and visibility for women's sports as she fought for equality – both on and off the court. Billie Jean King is a true American icon, one of the greatest examples our country has to offer and there's no doubt she should be awarded the Congressional Gold Medal."

"I am incredibly excited that after just finishing the 2023 US Open – where we celebrated the event's 50th anniversary of awarding equal prize money to men and women champions – and in a year where a new American woman champion was crowned

in the amazing Coco Gauff, that Senators Gillibrand, Capito, and Sinema have introduced legislation in the Senate to recognize Billie Jean King with the Congressional Gold Medal," said USTA Chairman of the Board and President Brian Hainline. "Billie Jean has utilized her status as both a champion of tennis and as an American icon to fight for equality in all aspects of life. Her legacy and impact are embodied by these three women who have introduced this legislation, and in the Coco's phenomenal lift of the US Open trophy. It is only fitting that today, on the 50th anniversary of Billie Jean King defeating Bobby Riggs in the 'Battle of the Sexes,' that this legislation is being put forth in the Senate."

Since the American Revolution, Congress has commissioned gold medals as its highest expression of national appreciation for distinguished achievements and contributions to society. To date, an individual woman athlete has never received the Congressional Gold Medal. Previous athletes who have received the Congressional Gold Medal include Jackie Robinson, Jesse Owens, Roberto Clemente, Jack Nicklaus, Arnold Palmer, Byron Nelson, Willie O'Ree, Greg LeMond, Larry Doby, Joe Louis and the 1980 Summer Olympic team.

The legislation is endorsed by the United States Tennis Association.

Hochul Signs Rozic/Ramos Legislation to Ensure Language Access Services For Injured Workers

Governor Kathy Hochul signed into law a groundbreaking piece of legislation championed by Assemblymember Nily Rozic (D-Queens) and Senator Jessica Ramos (D-Queens), marking a significant milestone in workers' rights and language accessibility.

A5609/S6069 directly addresses the language access needs of employees with limited proficiency in English, with a special emphasis on cases involving workers. This bill streamlines the language access standards within the workers' compensation law. Its resounding passage through both houses of the Legislature in May underscores its broad-based, bipartisan support.

'It is crucial that the needs of all employees, regardless of their English proficiency, are served, especially those workers who seek assistance and intervention from Workers Compensation Boards," said Assemblymember Rozic. "By ensuring consistency across agencies, we are providing transparency and easier access to workers' benefits to the many employees across the state whose first language is not English. I thank Governor Hochul for signing this crucial piece of legislation into law."

"Support that the State is able to offer is only valuable if people know about it. Workers' compensation is an economic stabilizer for families that rely both on the ability to heal and the paychecks that keep them afloat. Assemblymember Rozic and I represent some of the most diverse zip codes in the entire country, and we know that policy is only as good as its implementation. I'd like to thank the Governor for signing this bill and prioritizing measures that working families in my district rely on," said State Senator Jessica Ramos.

"As immigrant workers continue to be amongst the most vulnerable to workplace hazards, language accessibility must always be a top priority for policymakers," Asian American Federation Executive Director, Jo-Ann Yoo, said. "We are grateful to Governor Hochul for signing A5609/S6069 into law, and to Assemblymember Rozic and Senator Ramos for demonstrating their concern for our most susceptible populations and emphasizing the need for clear, consistent, and impactful regulations that address language access. Our immigrant workers, the drivers of our state's economy, deserve nothing less."

The Coalition for Asian American Children and Families (CACF) applauds Governor Hochul for signing Assemblymember Rozic and Senator Ramos' bill A5609/ S609 into law. This new legislation will help ensure Limited English Proficient (LEP) injured workers are provided necessary language access services in order to receive their Workers' Compensation benefits," said Vanessa Leung and Anita Gundanna, Co-Directors of CACF. "Language barriers are a huge obstacle faced by many folks in immigrant communities and can prevent them from accessing essential services. Workers' Compensation is a critical program for the wellbeing of injured workers and this bill helps ensure that LEP injured workers receive the benefits they are entitled to. Proper language access is necessary to achieve health equity and this bill is an important step towards a more equitable health care system."

"This commonsense law will make it easier for immigrant workers with limited English proficiency to access essential benefits when they're injured on the job," said Thomas Yu, Executive Director of Asian Americans for Equality (AAFE). "We are grateful to Assemblymember Rozic and Senator Ramos for standing up in support of some of our most vulnerable community members and to Governor Hochul for signing this legislation."

This legislation builds upon the success of Senator Ramos and Assemblymember Rozic's 2022 law that requires the Workers' Compensation Board to provide translations of specific documents and forms.

Rep. Velázquez Re-introduces a Bill to Ban All Neurotoxic Pesticides

Rep. Nydia M. Velázquez (D-NY) reintroduced the Ban All Neurotoxic Organophosphate Pesticides from Our Food Act. This straightforward piece of legislation would prohibit the use of organophosphate pesticides in food. Organophosphates are human-made chemical substances that are used on crops and have been shown to pose health risks to farmworkers and can affect children's neurodevelopment and neurological function, including by exposure before birth.

"We've known for decades that Organophosphate pesticides are a dangerous neurological threat to farmworkers and our children," said Congresswoman Velázquez. "These pesticides during early life have been linked to irreversible harm to the developing brain, which can result in long-term effects like attention disorders, autism, and reduced IQ. We can no longer wait to act, I'm proud to have introduced this legislation which will finally ban the use of these hazardous pesticides."

This legislation is cosponsored by Reps. Nanette Barragán (D-CA), Jamaal Bowman (D-NY), Grace Meng (D-NY), and Jan Schakowsky (D-IL).

"Toxic chemicals have no business being in our food, our drinking water, or poisoning the farmworkers who put that food on our tables each day," said Earthjustice Senior Legislative Representative Daniel Savery. "We can and must eliminate the use of organophosphates in food production. We thank Congresswoman Velazquez for her continued leadership in recognizing the need for Congress to step in and urgently act to protect workers, communities, and consumers from these dangerous toxins, particularly as the EPA continues to delay taking needed action."

"The UFW Foundation urges the EPA to ensure the protection of farmworker families who are on the frontlines of exposure to harmful insecticides," said UFW Foundation spokesperson Daniel Larios. "Organophosphates have no place in our food. To advance environmental justice, the agency must ensure that its decisions leave no farmworker behind. To protect ALL farmworkers, the United States must ban ALL uses of this neurotoxic pesticide and we will continue to advocate to that end."

"We cannot allow any more farmworkers, especially farmworker women and their families, to be exposed to pesticides. The reproductive health of too many farmworker women have been harmed," said Mily Trevino-Sauceda, executive director of Alianza Nacional de Campesinas. "Many have suffered complications during pregnancy. Too many children of farmworkers have been born with birth defects."

"Farmworker families across the country are struggling to raise children with learning disabilities, ADHD, and other neurodevelopmental problems due largely to their chronic exposure to agricultural organophosphate pesticides. With lack of access to necessary resources, these families struggle every day to make a living and provide for their families," said Jeannie Economos, Pesticide Safety and Environmental Health Program Coordinator, Farmworker Association of Florida. "Not only is this an incredible injustice to the men and women whose work feeds America, it is

tragic for their children's futures. Our communities suffer. Banning OP pesticides is a public health and justice issue."

"Farmworkers cannot achieve humane working conditions without the removal of poisonous pesticides; this country is completely dependent on farmworkers to provide food for our daily meals," said CEO of Farmworker Justice Ron Estrada. "Keeping them safe and healthy at work — as well as treating them with respect as we do all other essential workers — requires us to ban neurotoxic organophosphate pesticides."

"Farmworkers and their families have faced heavy exposure to organophosphate pesticides for far too long. Use of these dangerous pesticides must be ended," said Anne Katten, Pesticide and Work Health and Safety Specialist, CRLA Foundation.

"Farmworkers and their children, the health professionals who serve them, and others all agree, we cannot regulate away these hazards. OPs must be banned," said Margaret Reeves, Pesticide Action Network.

"We need to stop neurotoxic pesticides from poisoning the air we breathe, the water we drink, and the fruits and vegetables we eat," said Tracy Gregoire, Healthy Children Project Director for the Learning Disabilities Association of America. "Given the science demonstrating strong links to learning disabilities and other neurological impacts, organophosphates have no place anywhere near our food."

Attorney General James Scores Major Victory For Small Businesses Harmed by Predatory Lender

Richmond Capital Required to Cancel Tens of Millions of Dollars in Debt and Repay Thousands of Small Businesses Nationwide for their Predatory Loans

New York Attorney General Letitia James secured a major court victory against three merchant cash advance companies. Richmond Capital Group, Ram Capital Funding, and Viceroy Capital Funding (the Richmond companies) and their principals, Jonathan Braun, Tzvi Reich, Robert Giardina, and Michelle Gregg, for harming small businesses through high-interest loans and undisclosed fees. The lawsuit filed by the Office of the Attorney General (OAG) alleged that the Richmond companies' merchant cash advances, which are a form of short-term, high-interest funding for small businesses, were in fact illegal, high-interest loans with astronomical and illegal rates. The court order requires the Richmond companies to cancel the debt owed by thousands of small businesses nationwide and to repay all interest and overcharges collected, totaling tens of millions of dollars.

"Small businesses are the backbone of our economy, and

of all the challenges they face to stay open, predatory lenders shouldn't be one of them," said Attorney General James. "This decision will bring relief to thousands of small business owners in New York and across the country who were cheated by Richmond Capital. Small business owners were trying to get up on their feet when Richmond Capital crushed them with predatory loans that buried them in harmful debt. Richmond Capital will finally pay the price for the harm it caused for thousands of small businesses nationwide."

In June 2020, Attorney General James sued Richmond Capital Group, Ram Capital Funding, and Viceroy Capital Funding for a variety of offenses that were harming small businesses in New York and throughout the nation. Attorney General James found that the Richmond companies were illegally loaning money to small business owners at astronomically-high interest rates, fraudulently charging undisclosed fees, debiting excess amounts from merchants' bank accounts, and illegally obtaining judgments against merchants by filing false affidavits in New York State courts. In one example, the Richmond companies loaned

\$10,000 to a small business and required its owner to pay back \$19,900 within 10 days, through daily payments of \$1,999. As a result of the large daily payments and the short, 10-day repayment term, the annual interest rate for the merchant cash advance, including fees, came close to 4,000 percent — almost 250 times the legal interest rate.

The court decision requires Richmond Capital to stop collecting on its outstanding debt and to repay thousands of small businesses the unfair interest they had to pay. In order to determine the full amount of restitution, the Richmond Capital is required to provide an accounting and full history of monies collected.

This case was led by Assistant Attorneys General Jack Figura and Dami Obaro with assistance from Assistant Attorneys General Adam Riff and Christopher L. Filburn, law fellow Emily Smith, and former Data Scientist Chansoo Song under the supervision of Deputy Bureau Chief Laura Levine and Bureau Chief Jane Azia of the Division of Economic Justice. The Division of Economic Justice is led by Chief Deputy Attorney General Chris D'Angelo and overseen by First Deputy Attorney General Jennifer Levy.

message. "(He) didn't take anvthing for granted and was relentless which made it easy for labor to rally early and effectively."

Former Assembly Member Daniel Rosenthal, a moderate Democrat, resigned earlier this year to take a job at the UJA-Fed eration, opening up the seat for a special election. While the district has been represented by moderate Democrats like Berger for a long time, some of Berger's backers in the final days of the campaign expressed concerns that the race could be close, and even an opportunity for a Republican upset.

Berger won with large margins in Kew Gardens Hills and Electchester, while Hirsch won College Point, Whitestone and Beechhurst – the northern parts of the district that overlap with Paladino's City Council district.

"We need to send the message to Albany that we've had enough of a lot of these bad policies," Hirsch said earlier in the night, noting that his campaign focused on three key issues - crime, the asylum-seeker is and education.

Despite a significant fundraising advantage and dozens of high-profile endorsements, Berger and his backers have been pounding the pavement over the past week. City & State previously reported that Assembly Speaker Carl Heastie made calls to union leaders about the race, and that some of the large unions backing Berger have been out in force campaigning for him to ward off a Republican upset.







"As one of the largest providers of afterschool programming in the city, NYJTL is thrilled to kick-off another year of ACES, and provide tennis instruction and enrichment opportunities after the school day is done," said DJ Rouzeau, Chief Program Officer at NYJTL. "Rooted in character development and social learning, our services strive to provide future generations with tools they need to succeed."

Last year, following a nationwide increase in youth experiencing mental health concerns, NYJTL expanded its mental health counseling to a number of additional schools by hiring a full-time social worker to oversee its ACES sites. to governmental employees and their families.

"A job with the State is a rewarding career, and it's bills like these that ensure workforce equity, especially by getting the message out there to those seeking jobs in the public sector. By these bills being signed into law, we are making it clear that our governmental employees, the amazing men and women who work for our State, are supported, respected and appreciated," said Assemblywoman Pheffer Amato.

Bill A.6855 requires the State civil service department and municipal civil service commissions to issue announcements of competitive civil service examinations more broadly, opening the door to more accessible opportunities to prospective public employees. This includes civil service examination announcements to be issued to the local board of cooperative educational services (BOCES), all high schools, colleges, universities, local social services districts, and job training programs in New York. It is estimated that through Pheffer Amato's legislation thousands of more residents will be informed of career opportunities with the State which will successfully expand the State's workforce.

Bill A.7155 ensures that any time spent as a provisional State employee will be counted towards probationary time period upon being hired as a permanent employee. Due to the limited availability of civil service examinations, employees can be hired provisionally until a test is offered. Once hired permanently upon passing a civil service test, Pheffer Amato's legislation ensures that time spent as a provisional employee will count towards the required probationary period.

Bipartisan Lawmakers Push to Include Senate-Passed Amendment to Help Close World Trade Center Health Program Funding Gap in Final NDAA

On the heels of 9/11, a group of bipartisan senators and members are announcing a bipartisan push to include the Senate-passed amendment sponsored by U.S. Senator Kirsten Gillibrand (D-NY) and Senator Mike Braun (R-IN) to help address the funding shortfall in the World Trade Center Health Program (WTCHP) in the final version of the FY24 NDAA. Their amendment would deliver \$676 million for the WTCHP and allow excluded Pentagon and Shanksville responders to join the program. The Gillibrand-Braun amendment is modeled off the bipartisan 9/11 Responder and Survivor Health Funding Correction Act of 2023 and is fully offset by reforms that will reduce administrative costs in the federal government. The letter supporting this amendment is led by Senator Gillibrand and Representative Andrew Garbarino (R-NY-02), the House sponsor of 9/11 Responder and Survivor Health Funding Correction Act of 2023. The letter is also signed by Senator Braun, Majority Leader Charles Schumer (D-NY) and Representatives, Jerrold

Nadler (D-NY-12), Anthony D'Esposito (R-NY-4), and Dan Goldman (D-NY-10).

"This July, the Senate voted to uphold our promise to care for all those still suffering from 9/11-related illnesses by helping to close the funding gap in the World Trade Center Health Program. Those who need this program should not have to live in fear that it could run out of funding and go over a cliff. We will continue fighting until these heroic men and women can rest assured this program will always be there for them," said the lawmakers. "To honor those we lost and to thank those who risked everything to save their fellow Americans, we urge congressional leadership to include our amendment in the final NDAA conference report."

After years of efforts and calls on the federal government, Congress established the WTCHP on a bipartisan basis in 2011 with a five-year authorization to provide medical treatment and monitoring for 9/11 responders and survivors suffering from the effects of the toxins at Ground Zero. The program covers the lifespans of all exposed, including responders and survivors of the attack on the World Trade Center, the Pentagon, the Shanksville crash site, children who were in schools in downtown Manhattan on 9/11 and during clean-up, and those who have since experienced, or are expected to experience, adverse health effects that are linked to the attacks in the coming years. The program was reauthorized in 2015 and extended through 2090 with bipartisan support. In 2022, lawmakers delivered \$1 billion for the program in the end-of-year spending bill.

Today, eight years since Congress reauthorized the program, it is estimated that the funding formula in the statute will not be able to keep pace with the anticipated costs of providing the program's services for 9/11 heroes, who span all fifty states and 434 of the 435 congressional districts. Soon, the WTCHP will not have the funds needed to provide care for all those still suffering the physical and mental impacts of 9/11 and for those who have vet to be diagnosed with new 9/11-associated conditions caused by their toxic exposures.

Gillibrand Announces Legislation to Prevent Jobseekers From Being Kicked Off SNAP Benefits

If Jobseekers Earn Wages From Work Training Programs, They Face The Prospect Of Losing SNAP Benefits

Gillibrand: "Jobseekers Should Not Face The Impossible Choice Between Work And Food"

U.S. Senator Kirsten Gillibrand held a video press conference to announce her Training and Nutrition Stability Act, legislation to help prevent jobseekers from losing their SNAP benefits. The bill would rectify loopholes within the SNAP Employment and Training program that can cause a SNAP recipient to lose benefits due to receiving wages as part of their job training. By doing so, it would help ensure that SNAP recipients continue to receive critical nutritional assistance while gaining skills, working to secure employment, and eventually achieving selfsufficiency.

"Loopholes in SNAP's E&T program force job seekers to make an impossible choice: to participate in job training and potentially lose desperately needed nutritional assistance, or to give up employment opportunities in order to keep food on the table," said Senator Gillibrand. "My Training and Nutrition Stability Act is a commonsense fix that will provide jobseekers with sustained nutritional assistance as they seek to expand their skill sets and secure good-paying jobs so that they no longer need to rely on SNAP. I'm committed to getting this bill passed and making sure working families have the support they need to get back on their feet."

"People returning home from incarceration should have every opportunity to gain additional skills and job training to provide a better life for themselves and their families. However, right now, there's a 'Catch-22' in SNAP Employment & Training where an individual could be kicked off of SNAP due to the income they earn from a job training program," said Sam Schaeffer, Chief Executive Officer of Center for Employment Opportunities. "We thank Senator Gillibrand for pursuing a fix in the Farm Bill that will allow people to complete paid employment training that will support permanent independence – without having to compromise putting food on the table while they're doing it."

The SNAP Employment and Training program offers

a variety of services to help SNAP recipients secure employment, including work experience opportunities, job search assistance, and educational and vocational programs. It also offers participants a variety of supportive services to overcome other common barriers to sustained employment, like reimbursements for transportation, child care services, and safety equipment.

Under current law, SNAP E&T program participants risk losing their SNAP eligibility, and subsequently their ability to participate in the E&T program itself, because of the extra income they earn through the program. The Training and Nutrition Stability Act would fix this issue by excluding wages derived from a public workforce training program from SNAP income calculations. This change would allow participants to maintain their nutrition benefits and maintain their enrollment in high-quality training programs leading to better outcomes, permanent employment, and self-sufficiency. Rep. Adriano Espaillat

(D-NY), Rep. Alma Adams (D-NC), Rep. Max Miller (R-OH), and Rep. Marcus Molinaro (R-NY) lead this bill in the House.


